- Organizations whose core mission is to serve individuals/families who are unhoused or at risk of homelessness
- Organizations whose core mission is providing services to low- and moderate-income households, either directly or indirectly

Dues: **Operating Budget Over \$1 million**  
\$1,500/year

**Operating Budget \$500,000 - \$1 million**  
\$1,200/year

**Operating Budget Below \$500,000**  
\$750/year



- Aligned entities that work in the housing, homeless or community development sectors, or provide operational support or business services to organizations working in the housing, homelessness and community development sectors

**Dues:** \$500/year flat rate
